## SHORT DESCRIPTION OF THE INSURANCE COVER

The insurance cover does not apply to those applicants that have reached the age of 60 years.

### IF Insurance Company

The insurance covers medical costs up to EUR 10 000 per sickness or injury. The insurance covers both treatment given by a general physician and a specialist including medical tests and medicines.

Only costs for treatment in Finland is reimbursed.

The insurance covers following items:

- general physician, and specialist treatment
- you have the right to receive treatment everywhere in Finland
- prescribed medicines
- surgery and hospital care
- physiotherapy prescribed by physician (10 pcs) and needed in treatment of accidental injury
- patient fees within the public health care
- deductible EUR30 per medical consultation = (doctor's fee + cost for treatment + medicines ./ 30 €)
- the insurance cover is in force on a travel abroad lasting for a maximum of 45 days
